# 1. Call to Order

President Waskiewicz called the meeting to order at 7:01 p.m., followed by the Pledge of Allegiance and a Moment of Silence.

### 2. Approval of Agenda

## 7. Reports of the Superintendent for Information

# A. Start of School Year Update

Mr. Hamilton acknowledged the hard work of Mr. Moeckel on the new directional signs for the district. He stated the initial plan for the electronic sign board came in today but said there is additional information needed on site plan review to send to the state for this sign as well as the plans for the pole barn which will possibly to be located at the old track.

He informed the members that at the Jackson County Association of School Boards meeting to be held on September 29<sup>th</sup> there may be information presented on three different topics: a resolution to raise the minimum age of legal access to tobacco products, the Work Ethic Diploma which has come out of Kentucky and information regarding the County Common Calendar. There was additional discussion and questions about the county common calendar.

Also discussed was the current enrollment numbers which looks to have increased by approximately 25 students.

## B. Strategic Planning

An update was given on the STEM/STEAM initiative which is progressing very well. Mr. Hamilton stated we are very excited about it. There will be a parent meeting about the program on evening following this board meeting. The Leader in Me program falls under goal #4 and the Common County Calendar would also be fulfilling one of the goals.

### F. Approve Resolution to Approve the Reinstatement Committee

Mr. Hamilton explained that this process needs to be done each time a student has applied for reinstatement. The committee is to consist of 1 administrator, 1 teacher, 1 parent and 2 board members, with one of the board members to be appointed as a chairperson. Members Seaburg and Brown volunteered to be on the committee with Member Seaburg acting as chairperson. The names of a parent, teacher and administrator were given to the board. Mr. Hamilton briefly outlined the steps to follow for this process. A tentative date, time and location were chosen pending availability of all parties. The reinstatement recommendation will then be considered at the Special Board Meeting on September 28 for the approval of all members.

Moved by Member Hart, supported by Member Holcomb, to approve the appointment of the Reinstatement Committee as outlined. All present voted Aye. Motion Carried.
