# **Grass Lake Community Schools Regular Board of Education Meeting**

Monday, September 18, 2017 7:00 p.m.

George Long Elementary Library/Media Center

#### 1. Call to Order

President Brown called the meeting to order at 7:02 p.m. followed by the Pledge of Allegiance and a Moment of Silence.

#### 2. Approval of Agenda

Moved by Member Seaburg, supported by Member Waskiewicz, to approve the agenda as presented with the addition of item 10C – Introduction of Andrew Sullivan/New Liaison Officer, item 11J – Hiring of Amber Parker/ Special Education Aide, and item 11K- Resignation of Eric McCalla/ Assistant High School Principal/Athletic Director. All present voted Aye. Motion Carried.

#### 3. Approval of Minutes

Moved by Member Cole, supported by Member Burk, to approve the minutes of the Regular Meeting of August 14, 2017 and Special Meeting of August 30, 2017. All present voted Aye. Motion Carried.

#### 4. Presentation of Bills for Payment

Moved by Member Bisard, supported by Member Cole, to approve paying the bills for July 2017 in the amount of \$662,035.48. All present voted Aye. Motion Carried.

- 5. <u>Correspondence</u> as distributed to the board members.
- 6. Hearing of Citizens Member Brown explained there is a maximum of 30 minutes for the Hearing of Citizens portion, with a maximum of 5 minutes for each speaker. Making public comments were: Mark Fuller, Dale Foster, Dr. Daniel Shumer (Pediatric Endocrinologist with U of M), Chris Riggs, Carmelin Loveland, Jacqueline Bogdanski, Terri Nealy, and Robert Sutherby.

Member Brown stated the board had sought counsel and will be meeting next Monday in a closed session to address these issues further.

A five minute recess was taken.

The meeting resumed at 7:45 p.m.

#### 7. Interviews of Candidates for Open Position of School Board

President Brown introduced the candidates: Mark Burnett, Greg Cagney Jr., Amy Humbarger, Jamie Peacock and Gary VanSickle explained the process to be followed:

- The candidates will be interviewed in alphabetical order. Candidates #2 through #4 were excused to wait in the hallway. After introducing themselves, the candidates were each asked questions by the board members:
  - 1) What motivates you to become a board member?
  - 2) What role does policy play, and have, in the function of a school board?
  - 3) What is your vision of education in this community?
- Closing comments from candidates.

The applicants were asked to return and were thanked for their time and interest in applying for this position. The school board members were asked to write on individual ballots their top two choices of candidates. The ballots were collected and Dr. Kiser explained that the selections would be graded as 2 points for the first choice and 1 point for the second choice. The voting cards results were read:

- 1. 1<sup>st</sup> choice Mark Burnett, 2<sup>nd</sup> choice Amy Humbarger
- 2. 1<sup>st</sup> choice Amy Humbarger, 2<sup>nd</sup> choice Greg Cagney, Jr.
- 3. 1<sup>st</sup> choice Mark Burnett, 2<sup>nd</sup> choice Amy Humbarger
- 4. 1<sup>st</sup> choice Mark Burnett, 2<sup>nd</sup> choice Amy Humbarger
- 5. 1<sup>st</sup> choice Amy Humbarger, 2<sup>nd</sup> choice Jamie Peacock
- 6.  $1^{st}$  choice Amy Humbarger,  $2^{nd}$  choice Greg Cagney, Jr.

The votes were tallied:

- ➤ Amy Humbarger 9 points
- Mark Burnett 6 points
- Greg Cagney 2 points
- ➤ Jamie Peacock 1 points
- ➤ Gary VanSickle 0 points

Second round questions posed to the top two scoring candidates, Amy Humbarger and Mark Burnett:

- 1. Who should set the rules governing board procedures, methods and behavior, and who should enforce them?
- 2. What goals do you hope to achieve if you are appointed?
- 3. What is the most important responsibility of a school board?

There were comments by the school board members. A roll call vote was taken: Timothy Waskiewicz – Amy Humbarger, Kimberly Seaburg – Amy Humbarger, Janey Bisard – Amy

Humbarger, Aaron Cole – Amy Humbarger, Eric Burk – Amy Humbarger, Heather Brown - Amy Humbarger.

Amy Humbarger was appointed as new school board member.

#### 8. Swearing in of New School Board Member

Superintendent Kiser gave the Oath of Office to new board member Amy Humbarger.
