#### 1. Call to Order

Superintendent called the meeting to order at 7:00 p.m. via Cisco Webex. Dr. Kiser explained that all motions would be voted on by a roll call vote.

#### 2. Approval of Agenda

Bids were received from MDL Mechanical, John E. Green Company, and Boone & Darr, Inc. Dr. Kiser gave additional information for the board members to take into consideration. The bids from MDL Mechanical contractors and John E. Green Company did not include an additional step that may be needed which may increase these two bids by \$12,500.

Moved by Member Waskiewicz, supported by Member Seaburg, to accept the bid from MDL Contractors in the amount of \$44,900 with additional \$12,500 if needed, at Dr. Kiser's discretion. Comments: President Humbarger asked for the recommendation from the Facilities Committee. Member McClure gave a synopsis of the committee's recommendation. Discussion.

#### C. Bus Purchase

Comments: Mr. Moeckel explained the State Police standards had changed regarding life expectancy of buses. He then listed the age of two of our current buses and the need to replace these. Discussion.
