7. Reports of the Superintendent for Information

A. Administrative Reports –

- Mr. Moeckel: Michelle Clark completed her bus training in record time.
- Mrs. Clark: About 30 elementary students interested in summer school. M-STEP will begin when elementary students return to face-to-face learning.
- Mr. Thompson: testing make-up dates will be April 27-29. He wanted to thank the community for the support in the past year. Kudos for all students and the community for awesome support to the athletic program. This year our district had 3 sports teams win state titles, bowling, girls' basketball, and individual titles for gymnastics. This brings the total to 19 state championships for our district.

- Byerly: Will be rescheduling the testing. 5th grade will be visiting the middle school.
 8th grade celebration will be held outside. The "One School/One Book" is currently underway.
- B. Reconfirm Extended Learning Plan Dr. Kiser stated the plan is working well therefore no changes are needed at this time.
