1. Call to Order

President Humbarger called the meeting to order at 7 p.m. followed by the Pledge of Allegiance and a moment of silence.

2. Approval of Agenda

Moved by Member Bisard, supported by Member McClure, to approve the agenda with the addition of items: 8I – Hiring of Charlene Herrera, High School Secretary, 8J – Chromebook Purchase Approval, up to \$225,000, 8K – Google Chrome OS Mgt. License Approval, up to \$35,000. All present voted Aye. Motion carried.

3. Approval of Minutes

Moved by Member Bisard, supported by Member Hein, to approve the minutes of the Regular Meeting of April 12, 2021. All present voted Aye. Motion carried.

4. Presentation of Bills for Payment

Moved by Member Bisard, supported by Member Claussen, to approve paying the bills for March 2021 in the amount of \$725,886.41. All present voted Aye. Motion carried.

- 5. <u>Correspondence</u> A card to the board was passed around for each to read.
- 6. <u>Hearing of Citizens</u> Mr. VanSickle wanted to thank all the teachers, staff, administration, and board that have put students first and kept them in school this school year.

7. <u>Reports of the Superintendent for Information</u>

- A. Administrative Reports -
 - Mr. Moeckel Michelle Clark fully certified to drive bus. Custodial updates.
 - Mrs. Byerly –PSAT and MStep have been administered to students 6-8, NWEA begins this week. 8th graders to visit high school, 5th to visit middle school. The middle school has completed the year's emergency drills. Mr. Gogol was honored through the Walton Agency with the Good Things Going Teacher of the Month Award and was interviewed for JTV.

- Mr. Thompson –SAT testing complete. AP testing still ongoing. He gave the schedule of events for seniors. Freshman orientation is scheduled for the Class of 2025.
- Mr. Learned The elementary students have completed MSTEP, NWEA for K-2 began this week. Thank you to Girl Scout Troop #60136 who donated a box of cookies to all staff K-12 to honor educators. He gave an update on Kindergarten Roundup. Sandy Wolfinger received an award for being one of the Top 10 Teachers for Jackson County and was honored at a celebration on May 4th.
- Member Humbarger wanted to remind the board members of graduation on June 6th and to please let Mr. Thompson know if they are unable to attend.
- B. Reconfirm Extended Learning Plan Dr. Kiser stated the plan is working well therefore no changes are suggested. We will need to do this one more time.
- C. COVID Funding Plan Dr. Kiser referred to the PowerPoint printout put together by Janelle Sherwood. He reviewed the information about how the CRF (Coronavirus Relief Funds) were utilized. He also explained the requirements to use ESSER Funds and the district's proposed plans for the use of these allocated funds.
- D. Jackson County ISD Biennial Election June 7th. This is a consideration of the resolution that will be approved at the May 24th board meeting with representatives named for our district. An explanation was also given of the timelines and process for this election. The candidates filing deadline was today (May 10th).
- E. Reminder of May 24, 2021 Special Board Meeting This meeting will be held at 7:00 p.m. for approval of the resolution for the Jackson County ISD Biennial Election and the final report on the testing scores.

8. <u>Reports of the Superintendent for Action</u>

A. Athletic Trainer – Henry Ford Allegiance Health

Dr. Kiser explained that previously the district had used the services of Orthopaedic Rehab. The benefits of making this change to Henry Ford: significant cost benefits and continuing to keep the current trainer Andrew Andonian who is now employed with Henry Ford. Also, he will be a full year employee with Henry Ford and so will be available throughout the summer as well as during the school year.

Moved by Member McClure, supported by Member Bisard, to make the transition for the trainer services to Henry Ford Allegiance Health. 6 ayes, 1 abstention. Motion carried.

B. Football Field Sound System
