# Grass Lake Community Schools Regular Board of Education Meeting

Monday, August 9, 2021 7:00 p.m. Grass Lake High School Auditorium

## 1. Call to Order

President Humbarger called the meeting to order at 7:00 p.m. followed by the Pledge of Allegiance and a moment of silence.

## 2. <u>Approval of Agenda</u>

Moved by Member McClure, supported by Member Maynard, to approve the agenda as presented with the addition of item 8H – Hiring of Tracie Frailey – Elementary Special Education Teacher. All present voted Aye. Motion carried.

#### 3. Approval of Minutes

Moved by Member Maynard supported by Member McClure, to approve the minutes of the regular meeting of July 19, 2021, with the addition to item 7A-Two Tier Busing of wording stating that the incentive was offered to both new drivers and current drivers. All present voted Aye. Motion carried.

#### 4. Presentation of Bills for Payment

Moved by Member Bisard, supported by Member Hein, to approve paying the bills for July 2021 in the amount of \$1,056,885.21. All present voted Aye. Motion carried.

## 5. <u>Correspondence</u> –

6. <u>Hearing of Citizens</u> – Jennifer Marshall had questions regarding procedures for mask wearing. Dr. Kiser stated that, at this date, they are planning on masks as optional, no mandated mask wearing. He is waiting for a direct mandate from someone with authority that may change that protocol. Another person asked for this to be repeated and a clarification of possible vaccine mandate. Dr. Kiser repeated that until further information is received, the choice is left to the discretion of the parents and students. Sean Kelly had questions about the repercussions if someone refuses to wear a mask if it is mandated. Dr. Kiser explained that we are a state governmental agency and therefore required to follow state mandates or risk losing state funding. Discussion. A parent who chose virtual schooling last year wondered about her option of choosing virtual if the mandate changes. Dr. Kiser stated that currently there will not be a virtual option for for elementary students.

A question was asked about the procedure for a district-wide shut down. Dr. Kiser explained that the procedure would be handled the same as last school year with the entire district transitioning to virtual. He also stated that incidents of positive cases would also be handled the same as last school year with only the needed areas to be shut down, i.e. grade levels , etc.

  - B. Back to School Breakfast on August 23<sup>rd</sup> Dr. Kiser invited the board to join in welcoming the teachers back.
  - C. Member McClure asked there be a monthly update for two tier busing. Dr. Kiser said this could be added to future agendas. He also stated efforts are still being made to pursue other options.
